

**SIXTH JUDICIAL DISTRICT DEPARTMENT OF CORRECTIONAL SERVICES
PROBATION/PAROLE SEX OFFENDER CONDITIONS OF SUPERVISION AGREEMENT**

I RECOGNIZE AND ACCEPT THAT BY BEING PLACED IN THE Community Based Program for Sex Offenders, I am subject to the terms and conditions of the standard probation/parole agreement. In addition, I understand that I am subject to the special conditions that are established below.

- 1) I shall not initiate, establish or maintain contact with any minor, nor attempt to do so without prior written approval of my Probation/Parole Officer.
 - A. A Minor is defined as anyone under 18 years old.
 - B. Direct Contact is 1:1 contact with a minor. This includes in person visits, touching, talking on the phone, communication including electronic devices, letter or written notes, and making proximity contact with a minor.
 - C. Indirect Contact is making contact with a minor through another person, which includes asking the parent, teacher, or a friend to tell a minor something, or to have a minor answer questions, send pictures, deliver or receive packages, gifts, or money.
- 2) I shall have no contact or correspondence, to include direct or indirect contact, telephone contact, communication through electronic devices, or communication through a third party with the victim or victims without prior written authorization of my Probation/Parole Officer or their official designee. I shall not enter the premises of, travel past or loiter near where the victim resides except under the circumstances approved in writing by my Probation/Parole Officer.
- 3) I agree to complete assessments designed to address my sexually illegal behavior including but not limited to psycho-sexual evaluation, polygraph examination, and plethysmograph assessment.
- 4) I am prohibited from possessing any photographs (To include victims), drawings, magazines or other printed material, motion pictures, video recordings, or audio recordings that might contribute to inappropriate sexual arousal.
 - A. I shall not view, possess or have access to any material that depicts or portrays minor(s) or individuals representing themselves as minor(s) involved in sexual activity, nor patronize any place where such material or entertainment is available.
 - B. I shall not view or possess any picture, image or depiction of sexual acts including but not limited to magazines, computer images, photos, videos or DVD's. I will not possess or view any movie with a rating of "X" or "XXX" or any adult pay-per-view movies. I shall inform my Probation/Parole Officer of every DVD/video movie rental agreement that authorizes me to rent video tapes/DVD movies and allow my Probation/Parole Officer access to my video/TV accounts to verify compliance with this condition.
 - C. I will not own or possess any Polaroid cameras, camcorders, digital camera, camera phone, or web-cameras that could be used to record materials that might contribute to inappropriate sexual arousal.

- 5) I will comply with the Sixth Judicial Districts department policy on computer usage and monitoring. I will comply with this policy as explained in writing. (See Attachment B & C)
- 6) I shall abide by all rules and conditions of the group contract.
- 7) If my offense was against a minor, I will not knowingly be present within 100 yards of a park, school, day care center, swimming pool, beach, theater or other places where children under the age of 18 congregate without approval from my Probation/Parole Officer.
- 8) I will inform person I am dating of my offense, in detail. If my offense was against a minor, I am prohibited from dating or socializing or forming a romantic/sexual relationship with any person who has children without prior written approval from my Probation/Parole Officer.
- 9) I will comply with curfew hours as set by my Probation/Parole Officer. _____ to _____ hours, or as determined throughout supervision.
- 10) I will not enter establishments where the primary source of income is the sale of alcohol without the approval of my Probation/Parole Officer.
- 11) I will not utilize prostitutes, escort services, massage parlors, telephone sex lines, adult bookstores, or exotic dance clubs.
- 12) I will not hitchhike or pick up hitchhikers.
- 13) I will remain in compliance with all laws and statutes specifically enacted for sex offender management, to include the Sex Offender Registry, Public Notification, Residency Restrictions, Electronic Monitoring, Hormonal Intervention Therapy, and DNA testing.
- 14) I have been informed of and I will pay the fixed Sex Offender Program (SOP) Fee as required by the 6th Judicial District Department of Correctional Services (DCS).

ATTACHMENT B

1. Register ALL computers to which I have access with the Sixth Judicial District Department of Correctional Services. I will agree not to use any computer(s) that is not registered with the Sixth Judicial District Department of Correctional Services. I agree not to purchase, sell, replace or remove any registered computer without prior written approval from my Probation/Parole Officer.
2. I will not access any software installed by the Sixth Judicial District Department of Correctional Services not shall I alter or delete any files or software created by, or associated with said software. I will not attempt to disable, bypass or circumvent any software installed by the department. I will not install any software designed for the purpose of encrypting or erasing information. This includes, but is not limited to, the use of software or functions designed to boot into RAM kernels, alter, clean or "wipe" computer media, block monitoring software, or "restore" a computer to a previous state, including the reinstallation of operating systems.
3. I must obtain prior written approval from the Supervising Officer/designee to use an electronic bulletin board system, Internet realty chat channel, Skype, Vontage, DCC chat Channel, Instant Messaging or newsgroup, usergroup, peer to peer (e.g. Napster, Gnutella, Free net etc.) or any site-based e-mail which provides some measure of anonymity (e.g. Hot email, Gmail or Yahoo email.). Use of web camera or other recording devices is strictly prohibited.
4. Probation/Parolee understands and agrees that using the computer for any purpose which might further sexual activity is strictly prohibited. Such use includes, but is not limited to, the following: Possession of sexually explicit material in any form/sexually related "chat" or email exchange; visiting or joining "chat rooms" which contain sexually explicit conversations; visiting/viewing sexually explicit material on web sites; websites that contain nudity or sexually explicit conversations.
5. Probationer/Parolee agrees that he/she shall be prohibited from possession or viewing certain materials related to part of the grooming cycle for his/her crime. Such materials include, but are not limited to, the following:
 - Images of your victim
 - Stories or images related to your crime or similar crime
 - Images which depict individuals similar to your victims
 - Stories written about or for individuals similar to your victim
 - Materials focused on the culture or your victim (e.g. children's shows or web sites).
6. Probationer/Parolee voluntarily consents to unannounced examination by Supervising Agent/Designee of any and all computer(s) and/or electronic devises to which probationer/parolee has access for the limited purpose of detecting content prohibited by this document, conditions of probation/parole or court order. This consent includes access to all data and/or images stored on hard disks, "zip disk", floppy disks, CD ROMs, optical disks, maqnetic tape and/or any other storage media whether installed within a device or removable and separate from the actual computer device.

COMPUTER OWNER'S FORENSIC INTAKE AGREEMENT

The Computer owners' signature below indicates he/she declares to be the owner or duly authorized representative of the owner of the computers covered by this agreement and hereby acknowledges and agrees as follows:

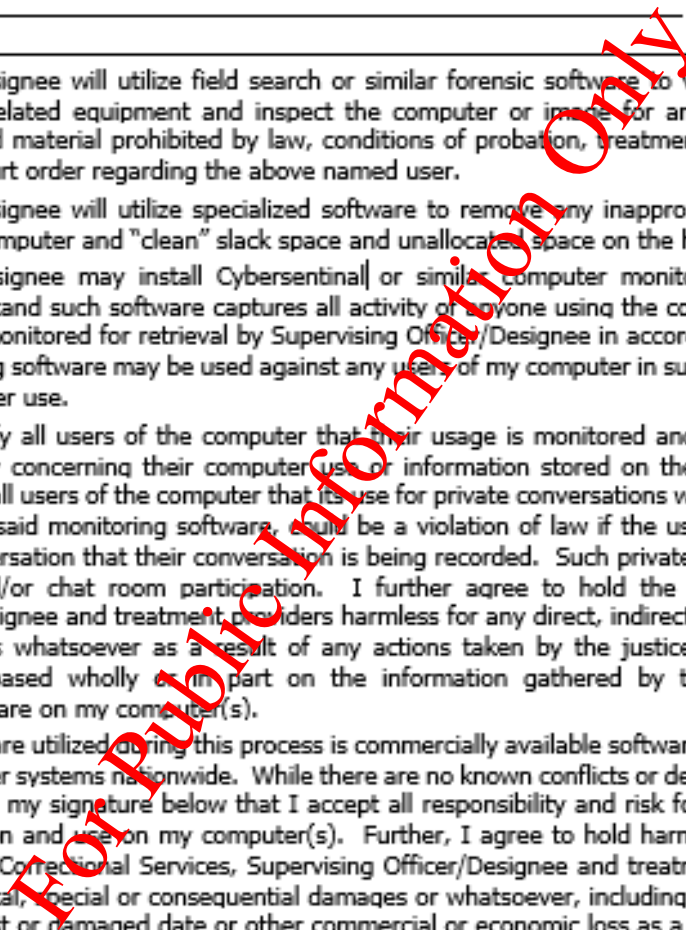
- 1) I understand I have the right to refuse the services listed herein and hereby voluntarily consent to and approve forensic computer intake services on my computer(s) as provided by the Sixth Judicial District in accordance with criteria stipulated by the Sixth Judicial District, Supervising Officer/Designee, treatment providers and this document.
- 2) Supervising Officer/Designee will catalogue and examine computer(s) and related equipment accessed by _____ (user) and located at _____.
- 3) Supervising Officer/Designee will utilize field search or similar forensic software to view and/or image my entire computer and related equipment and inspect the computer or image for any and all evidence of computer use or stored material prohibited by law, conditions of probation, treatment contracts, computer use agreements, or court order regarding the above named user.
- 4) Supervising Officer/Designee will utilize specialized software to remove any inappropriate or unauthorized material from User's computer and "clean" slack space and unallocated space on the hard drive(s).
- 5) Supervising Officer/Designee may install CyberSentry or similar computer monitoring software on my computer(s). I understand such software captures all activity of anyone using the computer. I understand the computers use is monitored for retrieval by Supervising Officer/Designee in accordance with established conditions of monitoring software may be used against any users of my computer in subsequent court actions regarding their computer use.
- 6) I hereby agree to notify all users of the computer that their usage is monitored and they should have no expectations of privacy concerning their computer use or information stored on the computer. I further hereby agree to notify all users of the computer that its use for private conversations with third parties, which would be recorded by said monitoring software, could be a violation of law if the user does not notify the participant in the conversation that their conversation is being recorded. Such private conversations include instant messaging and/or chat room participation. I further agree to hold the Sixth Judicial District, Supervising Officer/Designee and treatment providers harmless for any direct, indirect, accidental, special or consequential damages whatsoever as a result of any actions taken by the justice system or treatment providers which are based wholly or in part on the information gathered by the intake and/or the monitoring/filters software on my computer(s).
- 7) I understand the software utilized during this process is commercially available software applications installed and utilized on computer systems nationwide. While there are no known conflicts or defects in these software packages, I indicate by my signature below that I accept all responsibility and risk for the computer intake and software installation and use on my computer(s). Further, I agree to hold harmless the Sixth Judicial District Department of Correctional Services, Supervising Officer/Designee and treatment providers for any direct, indirect, incidental, special or consequential damages or whatsoever, including but not limited to loss of revenue or profit, lost or damaged data or other commercial or economic loss as a result of the computer intake and/or use of the monitoring software.

I understand and have read the above instructions and reviewed them with my supervising officer. I understand that failure to comply with these instructions may result in forfeiture of Internet usage up to, and including confiscation of the computer during my supervision. This also may result in court action, up to an including revocation of my supervision.
