I RECOGNIZE AND ACCEPT THAT BY BEING PLACED IN THE Extended Transition Program (ETP), I am subject to the terms and conditions of the standard Work Release Agreement, Board of Parole Condition 23, and the special conditions established below. Any violation of these conditions fall under the parole revocation process. I understand that violations could result in a Report of Violation being filed with the Board of Parole and I could be held in jail/prison pending the outcome of a disciplinary hearing held by the Administrative Law Judge.

1. I will attend and be on time to scheduled office appointments with my Probation/Parole Officer and complete a facility check in depending on which Phase I am on.
 - a. Facility Check Ins:
 - i. Phase I: Monday, Wednesday, and Friday (0700-2100 hours)
 - ii. Phase II: Monday and Friday (0700-2100 hours)
 - iii. Phase III: Friday (0700-2100 hours)
 - b. Probation/Parole Officer Appointments:
 - i. Phase I: One per week as directed
 - ii. Phase II: Two per month as directed
 - iii. Phase III: As directed
2. I will attend and be on time for all interventions/treatment as outlined in my DRAOR/Case Plan.
3. I will maintain full time employment (37+ hours) per week and, if I am interested in obtaining career track employment, I will secure permission from my Probation/Parole Officer prior to changing or quitting my job.
 - a. I will provide 2 pay stubs per month to my Probation/Parole Officer on Phases I & II.
 - b. I will provide 1 pay stub per month on Phase III unless directed otherwise by my Probation/Parole Officer.
4. I will call the urinalysis testing protocol line (319-730-1276) every Monday, Wednesday, and Friday. If my color is called for drug testing, I will report to the Residential Correctional Facility (women-Hinzman Center) (men-Nelson Center) as required per the UA Protocol.
5. I will make a \$63 payment each Friday if I am not current on my ETP fees. Failure to make payments on my fees may result in placement back in the Residential Correctional Facility without further order of the court. Money order or debit/credit cards are the only acceptable means of payment which can be made at the Residential Correctional Facility.
6. If I have valid Iowa driver's license, I will provide my Probation/Parole Officer with a copy of my license, proof of liability insurance and registration of the vehicle(s) I will be driving.
